The proclamation was designated during the regular meeting of the Fulton County Government Board on Tuesday, March 12th.

Grazing Workshop Set for June 28

Mark your calendars for Friday, June 28th; our first ever Grazing Workshop! The program will be held at the farm of Jim and Cindy Cassidy near Table Grove. The program begins at 9am, includes lunch, and will conclude at 3pm.

There will be no charge for Fulton County/Illinois Farm Bureau members. There is a \$20 charge for non-members.

Presenters for the day will be Luke Jones, consultant with Understanding AG. Luke has years of experience building the resiliency of cattle and sheep operations with regenerative practices. Luke encourages livestock growers to stop thinking of farming operations on a year-by-year agenda and start planning and building for down the road.

Additional presenters will be Lara Lant - from Midwest Grass and Forage, Keely Wilcoxen -Soil Conservationist with the Natural Resource Conservation Service, and Kevin Brooks – U of I Farm Business Management and Marketing Educator.

The program is generously sponsored by MidAmerica National Bank. Registration instructions and due date will be posted on our website and Facebook page in May.

Fisher Appointed To Waterway Ports Commission

FCFB President Barry Fisher has been appointed to serve on the Illinois Waterway (ILWW) Ports Commission. The commission was created unanimously by both houses of the Illinois Legislature and signed by the Illinois Gov. J.B. Pritzker last summer.

The goal of the Commission is to develop a Regional Inland Port to serve Central and North Central Illinois. The Port will protect the integrity of the supply chain and could successfully attract increased (and long overdue) government and private business investment to the region and ensure we have modern, dependable, and safe access to global markets.

The Commission also supports reginal economic development and sustainability goals. There is currently over \$1.5 Billion in projects now authorized by Congress for construction in the 10-County Illinois Waterway Ports Commission Area. But the region is at risk of losing access to these funds without a strong nationally ranked regional port advocate.

The ILWW Ports Commission is the only organization that can successfully implement a broad program to secure the federal funding that is available. he priority for the Commission will be securing funding through existing federal, state, and other programs for multi-modal transportation and natural infrastructure.

Per Illinois Department of Transportation, it is estimated that marine cargo activity being managed within the ILWW Ports Commission directly or indirectly supports 32,648 jobs within the state. These workers earn an estimated \$2.8 billion in wages and contribute approximately \$3.3 billion towards State GDP. The activity enabled comes from shippers across the state making use of facilities within the ILWW Ports, as well as the services supporting their movement of goods.

The Commission encompasses 10 counties, 5 state ports and 3 regional planning agencies. The Illinois River Basin includes 90% of the state's population, 46% of the state's agricultural production and 44% of the state's land area. A major goal of the ILWW Ports Commission is to reduce the costs of grain and agriculture product transportation and exports, to directly benefit farmers in Central and North Central Illinois.

The newly-formed commission held its first annual meeting recently at the Peoria Riverfront Museum. Barry will serve a vital role, providing input to the group and receiving updates on building out infrastructure for the ports.

APRIL BOARD HIGHLIGHTS

The Fulton County Farm Bureau Board of Directors met in regular session on Thursday, April 11, 2024, at the Farm Bureau office in Lewistown starting at 7:00 p.m. pursuant to due notice given. The meeting was called to order and presided over by President Barry Fisher. Other board members present were Robin Fisher, Levi Porter, Linda Rock, David Tolley, Delson Wilcoxen, Jeff Shelby, Nick Cleer, Seth Vohland, John Lock, Jason Chatterton, and Leah Brown. Also present was Manager Elaine Stone, District 8 Director Richard Carrol, and Stanci March and Blake Murphy from Doral Renewables.

Correspondence included an invitation to Cuba FFA Banquet on May 5th, thank you notes from Michelle Spiva, Sue Barth, Katie Baker, Ashley Tarochione, Makenna Johnson, Canton FFA chapter, and the Lewistown FFA chapter. We received some lovely St. Patrick's Day cards from our adopted class, as well as thank you notes for our lamb visit.

District 8 Director Richard Carrol gave an Organizational Member Strategy (OMS) recap. In June, the IAA Board is going out to meet with Ohio Farm Bureau, who is in the process of this same organizational direction study. Richard is on the Rural Medical Student Assistance committee. RIMSAP started in 1948 and is sponsored by the Illinois Farm Bureau and the Illinois State Medical Society. It is designed to provide doctors in rural communities in Illinois. This year 7 contracts were offered – 4 from district 8. He is also on the IFB rural veterinarian board and they will be awarding veterinarian scholarships at the next meeting. He will be running

for district director again.

Stanci March and Blake Murphy with the solar company talked about the Buckheart Solar project. They do not have plans for a battery storage area for this project. They are at the forefront of agrivoltaics – the intermeshing of farming and solar projects. Their programs involve 1200 head of sheep, mint cropping, low growth bee pollinator crops and bee hives, growing popcorn between arrays and between project and fence line. They are working through the approval process and looking at potentially breaking ground in 2027.

There were no affiliate reports. The minutes from the March meeting were emailed and mailed out before the meeting for the board members to read. These were approved with no corrections. Linda Rock discussed the financial statements for March. These were placed on file for audit.

Jeff gave the membership report. In total, we have 960 regular members at the end of previous month, 11 professional members, and 1533 associate members for a total of 2504 members.

Committee Reports were given. Young Leaders – No report.

Ag in the Classroom- Robin reported classes are finishing up incubating eggs. There were 11 classrooms that hatched eggs. In April they will be learning about worms and soil. The filled egg fundraiser brought in around \$300 for AITC. Barry, Robin, and Elaine took a pair of lambs to Chicago to visit the adopted class. While there, they saw the entire school on 211 students. There is a AITC freezer meal fundraiser April 22 & 23. Linda will be writing the class in April.

Local Issues – Directors discussed local solar projects

Legislative- David reported that IFB put out a call to take action on the wetlands bill.

Marketing – Levi reported that corn is down \$0.05 to \$4.30. Beans are down \$0.05 to \$11.55. Cattle prices are up. There is a scare

Also present was Manager Elaine Stone and West Central FS manager Jim McNeely.

The first order of business was Officer Elections: Jeff Shelby was voted in as the new Vice President. Robin Fisher was voted in as the new Secretary. Linda Rock was retained as Treasurer.

Affiliate Reports were presented. Jim McNeely – West Central FS – noted that March is Farm Bureau & FFA donation month and they will be sending checks out. New Director training for their newest director Wes Strode and John Livermore was just conducted. New and exciting technology is being introduced and piloted including soybean genetics that will display markers when disease begins appearing. Dicamba is still able to be used in 2024, but most of their customers have shifted away to insite and they are using up their stock to wait and see about 2025.

The minutes from the February meeting were emailed and mailed out before the meeting for the board members to read. These were accepted without changes. Linda Rock discussed the financial statements for February. These were placed on file for audit.

Local Issues — County has settled the employee contracts that were up. The County Recreation Area campground near St. David has a new manager. Time clocks have been installed for all county employees. The county has put out a proclamation for ag week.

Legislative- Congressman Sorenson had planned to be at the Fairview Sale Barn today, but his plan was changed and he and his assistant didn't make it. The topics they were to talk about words like almond milk, meat labeling and the definition of meat and how beef can't be used on fake meat. Country of origin meats – if meat is imported and processed in the US, it's considered US origin meat. He hopes to reschedule. Marketing – Corn is down \$0.07. Beans are down \$0.01 to \$11.91. Wheat is down \$0.12. Livestock prices are going through the roof. An 1800 lb cull bull brought \$1.61/lb. 100 lb calves brought \$800/head. Bucket calves bringing \$600. 1200+ lb fats still around \$1.88/lb. Slaughter plants are cutting back on numbers slaughtered and there is a shortage of cattle.

Business Service – We have had a contractor come look at a complete remodel of all the building bathrooms, but we have not yet received a bid.

Promotion and Education – Ag week is coming up and directors discussed the MANY events we have planned.

Manager's Report – Elaine reminded Directors of important dates of interest forms were passed out to be signed. 2023 goals were passed out to be looked at. Leah & Elaine went to new director training.

Old Business

- A) Policy Development meetingsheld in early March were very well attended. IFB's Mark Rainy spoke at Bernadotte. Barry spoke at the Canton meeting as there was a conflict of interest for the scheduled speaker.

Landowner Education Series Workshops

University of Illinois Extension is partnering with Fulton County Farm Bureau to host a 3 part educational series on helping farmland owners better understand their farm and come to informed decisions on setting cash rent or estimating how your farm compares to other farms as a farmer or an owner.

The first session will be at 2pm on Tuesday, June 18th at the Farm Bureau Building, and will focus on how to analyze a farm for productivity and fertility in order to establish cash rent and leases. Basics of leases and land stewardship will be covered.

In the first session, farm productivity will be analyzed. The most often asked question asked of University of Illinois Extension regarding agriculture centers around "how much should I charge for or pay for cash ren."

That's a tough question to answer unless more information is provided to help establish how productive soils are on a farm. Yield history helps to figure this out, but more information is needed. Your farm has identified soils that are rated in comparison to other soils in your area and across the state.

Additional meetings of the series will be held on specific topics in early September and in January/February. Register for the June 18th meeting by calling our office at 547-3011. There is no charge for Farm Bureau members, and a \$10 fee for non-members to attend.


